The supplied agencies have been released payment to the extent to the supplied material after receiving the acknowledgments from the MEOs concerned.

Regarding the districts which have not been supplied yet with the Book Shelves from the agencies concerned for Upper Primary Schools, the budget is released to School Management Committees as financial year was over along with specifications of the Book Shelves.

As per the norms of Government of India the SMCs are at liberty to decide the supplies as per specifications communicated. In this connection certain agencies like M/s New Prem Agency, Mahabubnagar has come forward with a proposal for supply of Book Shelves to Upper Primary Schools with the same specifications at the lowest rate of Rs. 8350/- only.

In this regard all the Project Officers of RVM in the state are reminded and directed to inform all the SMCs of all Primary and Upper Primary Schools that the complete liberty is given to School Management committee for taking decision regarding quality, price and agency for supply of Book Shelves and Book Rack both for Primary and Upper Primary Schools. They need not give the order to agencies suggested by this office earlier, funds are to be utilized in the best interest of school, going for a good quality and all the procurement shall be made in transparent manner.

With reference to the circular vide references 1<sup>st</sup> and 2nd cited, all the District Educational Officers and the Project Officers of RVM(SSA) in the state were informed and clarified that the fixed amount of Rs. 8350/- (Rupees eight Thousand Three Hundred and Fifty only) may be paid towards the cost of Book Shelves to Upper Primary Schools purchased as per specifications already communicated irrespective of make & firm as this is the lowest rate. The SMCs will be held responsible if any excess payment is made towards purchase of Book Shelves to UPSchools.

Therefore the District Educational Officers and the Project Officers of RVM(SSA) in the state are requested to inform to all the Head Masters and SMCs of the schools to strictly follow the said directions while purchasing book shelves to UPSchools and UP Sections of High Schools.
