ORDER:

The Chief Executive Officer, A.P.State Wakf Board, Hyderabad, in his letter 2nd read above, has requested to declare the Optional Holiday on 14.11.2013 (Thursday) instead of 13.11.2013 (Wednesday) on account of 9th Moharam & General Holiday on 15.11.2013 (Friday), instead of 14.11.2013 (Thursday), on account of 'Moharram', as per the moon sight.

2) The Government, after careful consideration of the matter, decided to change the Optional Holiday from 13.11.2013 (Wednesday) to 14.11.2013 (Thursday) on account of 9th Moharam and General Holiday from 14.11.2013 (Thursday), to 15.11.2013 (Friday), on the occasion of 'Moharram'.
