




AGREEMENT BETWEEN THE SAMAIKYA ANDHRA UPADHYAYA PORATA SAMITHI AND TEACHERS JOINT ACTION COMMITTEE AND THE GOVERNMENT (SCHOOL EDUCATION) HELD ON 10.10.2013

The representatives of the Samaikya Andhra Upadhyaya Porata Samithi and Teachers Joint action Committee and the Government on behalf of School Education Department have discussed the matter and, after detailed discussions the following decisions are agreed upon:

- i. As regards the demand to keep the AP State united, the matter rests and falls within the purview of Government of India. However, the Hon'ble Minister for Secondary Education agreed to convey the strike under taken by the teachers and their sentiments to the State and Central Governments.
 - ii. It is agreed that the period of absence from 22.08.2013 to 10.10.2013 will be compensated by working for 33 days on holidays and which will be treated as duty
 - iii. This shall apply for all Teachers/HMs/ MEOs/Principals/ /CRTs/, apprentice teachers, Vidya Volunteers/Outsourcing Employees working in all the schools/ Residential Schools under all managements and Residential institutions Lecturers in DIET, CTE, IASE and all non-teaching staff working, in the schools/Residential Schools.
 - iv. In pursuance of the above agreement the Samaikya Andhra Teachers Joint Action Committee agreed and assured that all the teachers and non teaching staff will resume work with immediate effect.
 - v. As regards the request to withdraw ESMA orders, it is clarified that the same have not been invoked so far against any of the employees.
