The attention of the Collectors & District Election Officers of Srikakulam, Vizianagaram, Visakhapatnam, West Godavari, East Godavari, Krishna, Guntur, Prakasam, Nellore, Chittoor, Kadapa, Kurnool, Anantapur, Adilabad, Nizamabad, Karimnagar, Medak, Warangal, Khammam and Nalgonda districts and Electoral Registration Officers of East-West Godavari Graduates, Krishna-Guntur Graduates, Medak-Nizamabad-Adilabad-Karimnagar Graduates, Srikakulam-Vizianagaram-Visakhapatnam Teachers, Warangal-Khammam-Nalgonda Teachers and Medak-Nizamabad-Adilabad-Karimnagar Teachers Constituencies is invited to the references cited. They are informed that it has come to the notice of the Chief Electoral Officer that certain designated officers are not accepting the applications in form-18 and 19 which do not contain the photographs and Assembly Constituency enrolment details viz., Name of AC, Part No., SI.No., and EPIC No. of the applicants and the applications of one institution, who are residents of various parts, with one covering letter and insisting for separation of applications with reference to their place of residence and to submit them to appropriate designated officer.

2. In view of the above, the following clarifications are issued for strict compliance:

- (i) The collection of details of AC enrolment is only an additional information to be obtained from the applicants along with the Form-18 & 19 on a separate piece of paper, so as to prepare photo electoral rolls for Graduates' and Teachers' Constituencies. It is not mandatory to furnish / obtain the said information by the applicants/by the designated Officers at the time of filing application. Hence, the Forms 18 & 19 shall not be refused with the reasons that the applicant has not attached photograph / Assembly Constituency enrolment details. However, applicants may be asked to submit the photographs at the time of verification of the residence.

- (ii) the applicants of Council Constituencies, who were not already enrolled for Assembly Constituency, can submit applications in Form-6 for their enrolment in Assembly Constituency along with the Form-18/19 for Council Constituency.
- (iii) The Heads of Institutions can submit all the applications of their staff members with one covering letter to the nearest designated officer, though they may reside at various parts of the Constituency. The designated officer, on receipt of those applications, shall separate with reference to their place of residence and forward to the AERO/Designated Officer / BLO concerned for verification and report to ERO.
- (iv) The lists in Form-9, 10, 11 & 12 of the claims and objections received in Form-18/19, 7, 8 & 8A respectively shall be displayed on the notice board of the ERO for public verification for a statutory period of 7 days before their disposal by the competent authority.

3. The District Election Officers and Electoral Registration Officers of ongoing Council revision constituencies are, therefore, requested to issue necessary instructions to all the AEROs/Designated Officers/Booth Level Officers for strict compliance of the above clarifications.
